

BOOK YOUR CORPORATE FUN NIGHT!



Hosting a fun night for your company employees and their families?

Lost in Fun will accommodate all your fun ideas to make it a successful unforgettable night.

We do have possible options that can be adapted to your company needs and goals:

Option 1: Rent part of Lost in Fun.

- ☺ Private Party for 2 or 3 hrs., Monday - Friday only.
- ☺ The use of three private party rooms.
- ☺ Lost in Fun staff greeting the guests.
- ☺ Lost in Fun staff monitoring the kids.
- ☺ Lost in Fun will be open to the public.

PACKAGE 1) 1-50 kids, a minimum payment of \$300.00 is required for 1-30 kids. Additional kids \$7.00 each. *Facility opened to the public.*

Option 2: Rent out the entire Lost in Fun facility

The packages will include:

- ☺ Private Party for 2 or 3 hrs., Monday - Thursday only.
- ☺ The use of the party rooms, if needed.
- ☺ Lost in Fun staff greeting the guests.
- ☺ Lost in Fun staff monitoring the kids.

PACKAGE 2) 1-50 kids, \$475 *facility closed to the public.*

PACKAGE 3) 51-100 kids, \$ 600 = \$6.00 per child w/ adult guests **41.5% SAVINGS**. *Facility closed.*

PACKAGE 4) 101-150 kids, \$725 = \$4.83 per child w/ adult guests **53% SAVINGS**. *Facility closed.*

PACKAGE 5) 150-200 kids \$850 = \$4.25 per child w/ adult guests **58.5% SAVINGS**. *Facility closed.*

PACKAGE 6) 201-300 kids \$1,200 = \$4.00 per child w/ adult guests **61% SAVINGS**. Additional kids after 300, \$3.00 each **71% SAVINGS**. *Facility closed.*

If food is requested, Lost in Fun will discount **10% off** the regular price for food and drinks, with extra personnel included to serve and cook food. Laser Maze Deal: **\$1.00** per token for each Lost Temple Laser Maze game (**33% off**). Arcade games are at a separate cost and will require quarters to play.

As for outside food the Health Department requirements states: **“Food must never be brought in from home. Doing so could result in a permit being suspended or revoked”** Therefore Lost in Fun can’t accept food that is not prepared at a facility following their rules and regulations.

Just let us know the date or dates you are thinking about and Lost in Fun will check the availability!

Requirements:

A \$100 deposit must be paid when reserving the event. Deposit goes towards the final balance and is non-refundable, but can be rescheduled.

The remaining balance will be due at the end of the event. If paying at a later date, LIF will give the responsible company contact the invoice. Payment should be within seven days after the event.

Lost in Fun! will accept business checks only (no personal checks). MasterCard, Visa, Discover Credit Cards and/or cash are also accepted.

Lost in Fun! will need a responsible company contact at all times during the event for LIF to finalize details and make a payment.

The customer is to notify Lost in Fun of changes and final totals one week prior to the event. Packages can be upgraded, but no downgrade will be allowed once final totals are given.

Rules:

Every customer should sign the waiver at the entrance and read all posted safety signs.

If playing, socks must be worn all the time. The company is responsible of letting their employees know. If not brought, either the company or the guest is responsible to get or buy them. Socks are available for purchase at Lost in Fun!

Prices do not include taxes unless you are tax exempt.
